In 1984, I was a Journalist in Caracas, Venezuela where I witnessed 3 Members of the RCMP from the Canadian Embassy in Caracas, Venezuela executing an innocent man in cold blood. I was at the wrong place, at the wrong time, and I took photos of the execution at a distance with my camera.

The RCMP from the Canadian Embassy followed me to Miami International Airport and the same three RCMP Officers tried to murder me at the Miami International Airport in the Public Washroom. I suffered severe head injury and my skull was cracked in 3 places. I lost my memory for about 30 years.

In 1985 the RCMP ordered me to report to their detachment and I did. I was again attacked at the RCMP detachment and my head was split open. My Passport was illegally stolen by the RCMP and so were all, of my Identifications.

This was at the same, time that Former Prime Minister of Canada Brian Mulroney illegally stripped me out of my Canadian Citizenship. This was the last time I ever had a Canadian Passport.

A contract was placed on my head at that time by Canadian Politicians and Canadian Prime Ministers.

In 1995, I discovered that the RCMP were illegally using the Canadian Embassies and Canadian Consulates Worldwide to ship massive drugs using Diplomatic Bags and Diplomatic Cargo. As a Journalist and a Reporter at that time, I wrote an article with all evidence that I legally obtained from the RCMP main frame. I suffered another severe head trauma, back injuries, and other injuries and I became disabled for the rest of my life. I was in a coma and I was placed on a Life Support Machine. The RCMP illegally ordered doctors to shut off the Life Support Machine to murder me.

The RCMP gave me weekly beatings and no matter what Province I moved to, to escape the Persecution and Physical Torture, the RCMP were always there, beating me up and paying homosexuals to rape me.

When I was a Journalist, the RCMP made sure that my Articles were never published because I was exposing the massive corruption of the RCMP and some Canadian Politicians.

When I, Annette Martini, met my husband and soon married him, the RCMP started Persecuting me and illegally stole all, of my Money, Homes and my two Construction companies because I married my husband, Anthony Martini. The RCMP Persecuted me to no end in sight.

The RCMP illegally stole Millions of Dollars from me from my Bank Accounts without ever going to Court. This went on for Four Decades where the RCMP abused their power and ordered Bank Managers to steal my Money even when my taxes were all paid. They stole all, of my Homes. They stole and damaged over 28 of my

I, Anthony Martini was taken to the desert in California by my kidnappers, where I was Physically Tortured on Orders of CANADA, The Prime Minister of Canada Stephen Harper and by Orders of Canadian Minister of Foreign Affairs John Baird and by Orders of the RCMP.

I was Severely Beaten and then the majority of all of my Lost Memories, all came back. I suffered Severe Physical Injuries because of the Physical Torture that I received for nearly a year. I still suffer from my Physical Injuries to this day.

In September 2013, I, Anthony Martini and I, Annette Martini were illegally forced back to CANADA, against our WILL, by Prime Minister of Canada Stephen Harper and by Canadian Minister of Foreign Affairs John Baird. The RCMP started to immediately STALK us as soon as we went into a Church.

We immediately visited SERVICE CANADA, located at 395 Ontario St. E & F, St. Catharines, Ontario to either reactive our old SIN numbers or give us new SIN numbers and the Head Office of SERVICE CANADA in Bathurst, New Brunswick totally refused to reinstate our old SIN or give us a New Social Insurance Number.

I, Anthony Martini and I, Annette Martini contacted the Canadian Passport Office and tried to obtain Emergency Passports to Leave Canada and again we were denied indicating that we both have, to prove that we are Canadians.

CANADA was involved in INTERNATIONAL KIDNAPPING, so the Burden of Proof does not rest on us to prove that we are Canadians or not. The sole responsibility rests on CANADA.

I, Anthony Martini need to have x-rays because of the Physical Torture that I received on Orders of Canada that lasted for almost one full year and the St. Catharines, General Hospital refused to give me any x-rays or do any blood work. CANADA ordered my kidnappers to put poison in my blood and I had a nose bleed every day for 2 years.

In November 2013, I, Anthony Martini and I, Annette Martini filled out forms with the Canadian Immigration and Citizenship to prove that we were Canadians, so we can get a PASSPORT and immediately leave Canada. Then we got the major run around indicating that it would take a long time. The RCMP that are a Terrorist Organization prevented us from getting any Passports or any Identifications or Free Medical from September 2013 to the current date.

The RCMP have also made numerous fake files to destroy my excellent reputation and my wife's reputation and to hide the real, truth about the RCMP a Terrorist Organization.
